# Scope of Work:

The contractor shall supply all drawings, labor and material to install backflow preventers at Indian Lake Elementary, Hawkins Middle, and Ellis Middle.

- x Contactorshall locate and excavate down to existing 6" main; saw cut and remove a portion of the underground pipe.
- x Contractor shall be responsible for removal of soils to an offsite location.
- x Contractor shall be responible for any necessary backfill.
- x Contractor shall install valve setters and repair coupling.
- x Contractor shall install ductile pipe to above ground level.
- x Contractor shall frame and pour slab for hotbox.
- x Contractor shallinstall hotbox and heater.
- x Contractor shall install a 6" RPBP with detector check and radio MXIRPBP shall be expl to or better than Febco or Watts brand equipment.

The new backflow preventer must be tested by a certified inspector. A copy of all paperwork must be sent to the Hendersonville Utility District and the School System.

If necessary, a site visit can be scheduled for each location.
