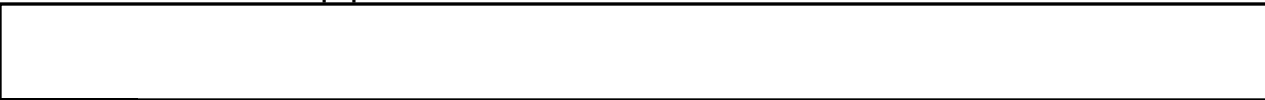

2. RFP/TB SUBMITTAL / SIGNATURE: Proposals give the full name and business address of the bidder. If the proposer is a corporation, the name shall be stated as it is in the corporate charter. Proposals must be signed in ink by the authorized agent. Unsigned proposals will be rejected. Proposals are to be sealed and the outside of the envelope is to refer to the RFP. The person signing the proposal must show the title, and if requested by the institution, must furnish satisfactory proof of his or her authority to bind his or her company in contract. Proposer understands that by submitting a proposal with an authorized signature, it shall constitute an offer to SCS. Proposals must be typewritten or in ink; otherwise, they may not be considered. Purchase orders will be issued to the firm name appearing on the W9. Electronic submissions via email, fax, etc. shall not be accepted.
